This is to advise that with effect from February 1, 2007, the applicable rate for the points within the New York (NY) / New Jersey (NJ) Commercial Zone will be adjusted as follows:

NY Commercial Zone: applicable New York rate plus US\$800 Per Container

NJ Commercial Zone: applicable New York rate plus US\$600 Per Container
